MINUTES OF SPECIAL MEETING MARCH 31, 2022

CALL TO ORDER

The Special Meeting of the Ocean City Board of Education was called to order by President Kane on Thursday, March 31, 2022, at 9:00 a.m. in the Ocean City Free Public Library – Chris Maloney Lecture Hall, 1735 Simpson Avenue, Ocean City, NJ.

OPEN PUBLIC MEETINGS ACT ANNOUNCEMENT

President Kane announced that adequate notice of this meeting was provided in accordance with the Open Public Meetings Act, Chapter 231, P.L. 1975. Notice of the time, place and agenda were filed with the city clerk, posted in the lobby of City Hall, and delivered to the <u>Ocean City Sentinel</u> and the <u>Press of Atlantic City</u>.

FURTHER RESOLVED that the Board of Education will not return to open session to conduct business at the conclusion of the executive session.
