MINUTES OF SPECIAL MEETING MAY 10, 2023

CALL TO ORDER

The Special Meeting of the Ocean City Board of Education was called to order by President Halliday on Wednesday, May 10, 2023, at 5:08 p.m. in the Ocean City High School Community Room, 501 Atlantic Avenue, Ocean City, NJ.
